12.3.2 Canada-Ontario Community Housing Initiative and Ontario Priorities Housing Initiative 2022-23 Investment Plan [Financial Impact - None], 2022-149

- A. THAT the report 2022-149 on the Canada-Ontario Community Housing Initiative and the Ontario Priorities Housing Initiative 2022-23 Investment Plan BE RECEIVED; and
- B. THAT the Canada-Ontario Community Housing Initiative (COCHI) and Ontario Priorities Housing Initiative (OPHI) 2022- 23 Investment Plan outlined in this report BE APPROVED; and

- D. THAT the Director of Housing and Homelessness Services BE AUTHORIZED to reallocate capital and operating dollars within the funding streams as may be necessary to facilitate total expenditures of the COCHI and OPHI funding allocations; and
- E. THAT the Director of Housing and Homelessness Services BE DIRECTED to fund the capital repair projects as identified in Appendix A to Report 2022-149 from COCHI and OPHI in the total amount of \$697,414; and
- F. THAT the Director of Housing and Homelessness Services BE AUTHORIZED to revise or add capital repair projects to Appendix A for

- funding from COCHI or OPHI, as may be needed, to ensure full expenditure of the allocations.
- G. THAT staff BE DIRECTED to send communication to the Ministry of Municipal Affairs and Housing in regards to the Homeownership component of the Ontario Priorities Housing Initiative recommending a review of the program in order to be more reflective of the current market, this would include, but not be limited to the eligibility criteria, purchase price, and eligible unit types.
