

BY-LAW NUMBER 40-2022

OF

THE CORPORATION OF THE CITY OF BRANTFORD

To amend By-law Number 144-88, being a by-law to regulate
Parking in the City of Brantford

WHEREAS Committee of the Whole – Operations of Council of the Corporation of the City of Brantford has recommended to Council for the improvement and better regulation of parking within the City of Brantford; and

WHEREAS Council desires to implement the recommendations of the Committee as aforesaid;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF BRANTFORD ENACTS AS FOLLOWS:

1. Memorial Drive – Parking Control

- a) RECOMMEND that Schedule “7” of Parking By-law 144-88 which pertains to “Parking Prohibited at Anytime” BE REPEALED as follows:

<u>STREET NAME</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING IS PROHIBITED</u>
Memorial Drive	South	From Fairview Drive to Hayhurst Road.
Memorial Drive By-law 38-2021	West	From North Park Street to a point 21 metres north of the centre line of Kensington Avenue.
Memorial Drive	North	From Fairview Drive to a point 60 metres west of the centreline of North Park Street.
Memorial Drive	North/East	From the centre line of Buckingham Street to a point 28 metres east of the centre line of Buckingham Street.

- b) RECOMMEND that Schedule “7” of Parking By-law 144-88 which pertains to “Parking Prohibited at Anytime” BE AMENDED as follows:

<u>STREET NAME</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING IS PROHIBITED</u>
Memorial Drive	South	From Fairview Drive to a point 60 metres west of the centre line of North Park Street.
Memorial Drive	West	From Hayhurst Road to a point 21 metres north of the centre line of Kensington Avenue.
Memorial Drive	North/East	From Fairview Drive to a point 28 metres west of

the centre line of Buckingham Street.

- c) RECOMMEND that Schedule "9" of Parking By-law 144-88 which pertains to "Parking Prohibited During Certain Time" BE AMENDED as follows:

<u>STREET NAME</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING IS PROHIBITED</u>	<u>DAYS OF WEEK PROHIBITED</u>
Memorial Drive	North	From North Park Street to Buckingham Drive	12 am to 6 am Every Day

2. THAT this by-law shall become effective upon the date of its passing, save and except that any provisions of this by-law affecting traffic on highways designated as connecting links, pursuant to Subsection 195(3) of The Highway Traffic Act, as amended, and Subsection 21(1) of The Public Transportation and Highway Improvement Act, as amended, shall not become operative until approved by the Ontario Ministry of Transportation.
