# 3.1.1 Support for Ukraine and Ukrainian Communities - Mayor Davis

Moved by Councillor Martin Seconded by Councillor McCreary

WHEREAS Ukraine is facing an unprecedented and unjustified attack on their people, their sovereignty, and their territory; and

WHEREAS We are deeply troubled by the situation on the ground, including images of hardship, violence and families seeking refuge in bomb shelters and in subway stations; and

WHEREAS The City of Brantford stands with the people of Ukraine, Ukrainian communities across Ontario and those around the world in strongly condemning this brazen and unprovoked attack; and

THEREFORE BE IT RESOLVED THAT Our thoughts go out to our respective Ukrainian communities and their loved ones during this deeply troubling time; and

THAT The City of Brantford stands for peace and are in full support of the strict sanctions the federal government has imposed on Russia; and

THAT The City of Brantford SUPPORTS the call for the immediate cessation of all military activity and instead pursue a diplomatic resolution; and

THAT Staff BE DIRECTED to raise the Ukrainian flag at Harmony Square symbolizing our solidarity; and

THAT a donation in the amount of \$10,000 BE MADE from the Corporate Contingency Reserve (RF0554) to the Canadian Red Cross – Ukraine Humanitarian Crisis Appeal; and

THAT The City of Brantford call on the Federal government to welcome those fleeing the conflict with Ukraine into our country with open arms; and

THAT City Staff BE DIRECTED to work with other levels of government, the Canadian Red Cross, Ukrainian communities and other organizations to determine how many refugees the City of Brantford can accommodate; and

THAT this Resolution BE CIRCULATED to AMO and FCM encouraging other municipalities to match the donation of \$10,000 made by the City of Brantford.
