THAT Section 15.11.5 of Chapter 15 of the City of Brantford Municipal Code BE WAIVED in order to introduce the following Notice of Motion without having been included on an agenda:

WHEREAS community members and neighbours have long expressed concerns regarding vehicle speed and driver behavior; and

WHEREAS The Corporation of the City of Brantford considers all appropriate measures to satisfy said concerns; and

WHEREAS The Corporation of the City of Brantford is committed to traffic calming measures; and

WHEREAS traffic calming measures have been implemented on Memorial Drive; and

WHEREAS best efforts by staff to implement excellent plans can be proven inadequate following implementation and experience lived; and

WHEREAS such is the case with the section of Memorial Drive limited on the east by North Park Street limited on the west by Hayhurst Road; and

WHEREAS neighbours have related negative experiences with the design and implementation of this section of Memorial drive; and

WHEREAS neighbours have diligently and democratically engaged all residents in the subject area and have demonstrated near unanimous support for this initiative; and

WHEREAS Councillors Martin and McCreary are in receipt of a petition endorsing this initiative;

NOW THEREFORE BE IT RESOLVED:

- A. THAT staff BE DIRECTED to carry out the following actions at the earliest opportunity:
 - i. Implement a temporary "no overnight parking" restriction of the aforementioned section of Memorial Drive; and
 - ii. Remove parking from the north (odd-numbered) side; and
 - iii. Implement parking on the south (even numbered) side; and
- B. THAT Ward Councillors be provided with a schedule for the proposed work.
