1.0 Type of Report

Committee of Adjustment Decision Regarding Application for Minor Variance

2.0 Topic

APPLICATION NO. A14/2022

APPLICANT/OWNER Issac Stewart

AGENT Pat Krolouski

LOCATION 73 Bishop Street

3.0 Recommendation

- A. THAT Application A14/2022 requesting relief from the City of Brantford Zoning Bylaw 160-90 to permit a minimum rear yard of 2.0 m, whereas a minimum rear yard of 7.5 m is required, BE APPROVED;
- B. THAT the reason(s) for approval are as follows: the proposed variance is in keeping with the general intent of the Official Plan and Zoning By-law, the relief requested is considered minor in nature and is desirable for the appropriate development and use of the subject land; and

C. THAT pursuant to Section 45(8) – (8.2) of the *Planning Act*, R.S.O 1990, c.P.13, the following statement SHALLE BE INCLUDED in the Notice of Decision:

"Regard has been had for all written and oral submissions received from the public before the decision was made in relation to this planning matter, as discussed in Section 6.2 of Report No. 2022-461."

4.0 Purpose and Description of Application

A minor variance application has been received for the lands municipally addressed as 73 Bishop Street. A location map is attached as **Appendix A**. The applicant is proposing to construct an addition to the existing dwelling. It should be noted that the proposed development does not include the construction of an additional unit. Two (2) existing sheds on-site are proposed to be demolished (refer to **Appendix B**).

To facilitate the development, a minor variance is required to permit a reduced rear yard of 2.0 m, whereas 7.5 m is required as per Section 7.8.2.1.6 of Zoning By-law 160-90.

5.0 Site Features

The subject lands are located on the western side of Bishop Street, east of Gordon Street, north of Mintern Avenue. The lands have an area of 390 m² and contain a single detached dwelling. The subject lands are located in an established residential area consisting of primarily single detached dwellings. An aerial photo is attached as **Appendix C**, and site photos are attached as **Appendix G**.

6.0 Input from Other Sources

6.1 Technical Comments

This application was circulated to all appropriate departments and agencies. No adverse comments or objections were received from the commenting agencies.

6.2 Public Response

Notice of public hearing was issued by personal mail (53 notices) and by posting a sign on-site. A plan illustrating the notification area is attached

as **Appendix D.** At the date of the preparation of this Report, no responses have been received.

7.0 Planning Staff Comments and Conclusion

7.1 Provincial Policy Context

Application A14/2022 was reviewed in the context of Provincial Policy, including the Provincial Policy Statement (PPS) and A Place to Grow: Growth Plan for the Greater Golden Horseshoe (Growth Plan). These policies set the standard to which provincial and local interests, policies and goals are implemented. The PPS outlines that Ontario's long term prosperity, environmental health, and social well-being depend on wisely managing change and promoting efficient land use and development patterns. The Growth Plan outlines the principals that provide the basis for guiding decisions in the Greater Golden Horseshoe on how land is developed, resources are managed and protected, and public dollars are invested. Planning Staff is of the opinion that the proposed minor variance application is consistent with the direction set out in the PPS and conforms to the Growth Plan.

7.2 City of Brantford Official Plan (Envisioning Our City: 2051)

The subject lands are designated "Residential" as per the City of Brantford's Official Plan (**Appendix E**). The "Residential" designation permits a full range of residential dwelling types and accessory buildings, as well as supporting land uses intended to serve local residents. The minor variance meets the intent of the Official Plan.

7.3 City of Brantford Zoning By-law 160-90

The subject lands are zoned "Residential Conversion (RC)" in Zoning Bylaw 160-90 (**Appendix F**). The "Residential Conversion (RC)" Zone permits single detached, semi-detached, duplex, triplex, converted dwellings, and Street townhouse dwellings, comprising a maximum of three attached dwelling units, etc. The minor variance meets the intent of the Zoning By-law.

7.4 Planning Analysis

When evaluating the merits of a minor variance application, the Committee of Adjustment must be satisfied that the four tests of Section

45 (1) of the *Planning Act* have been met. To be approved, a minor variance must be minor in nature, desirable for the appropriate development and use of the land, and the general intent and purpose of the Zoning By-law and Official Plan must be maintained.

The Official Plan encourages a wide range of housing types to accommodate the anticipated population. It is the opinion of Planning Staff that the proposal will maintain the general intent and purpose of the City's Official Plan.

Section 7.8.2.1.6 of Zoning By-law 160-90 requires a minimum rear yard of 7.5 m. The intent and purpose of this zoning provision is to ensure that units are adequately set back from neighbouring developments and to provide amenity space. The proposed development provides a minimum rear yard of 2.0 m. Given the unique configuration of the existing lot, Staff is of the opinion that the intent of the Zoning By-law is still maintained as adequate outdoor amenity can still be provided.

7.5 Conclusion

A site inspection was completed on June 28, 2022. Upon completion of this visit and review of all relevant policies, Planning Staff are supportive of the application. The proposal will contribute to a broad range of housing options in Brantford in accordance with the applicable planning policy framework in the PPS, Growth Plan, and Official Plan. It is Planning Staff's opinion that the variance satisfies the four tests as defined under the *Planning Act*. The application is minor in nature, appropriate for the development and use of the lands, and meets the intent of the Zoning Bylaw and Official Plan. Planning Staff recommend that application A14/2022 be approved.

The minor variance as proposed will facilitate appropriate development that makes efficient use of land. This type of residential development represents good land use planning that is encouraged by the *Planning Act*, the PPS, the Growth Plan, and the Official Plan.

For the reasons mentioned above, the minor variances satisfy the criteria of Section 45(1) of the *Planning Act*, and Staff recommends that application A14/2022 be approved.





LOCATION MAP Application: A14/2022 73 Bishop Street




Appendix B – Concept Site Plan


