- E. THAT subject to the successful negotiation of a Facility
  Lease/License Agreement with the Hamilton Bulldogs, the City
  Clerk BE DIRECTED to place the Facility Lease/License
  Agreement on the Signing By-Law for execution by the Mayor and
  Clerk; and
- F. THAT subject to the execution of a Facility Lease/License Agreement with the Hamilton Bulldogs, the following capital requirements BE FUNDED from the Casino Legacy Reserve RF0555:
  - i. installation of a heating, ventilation and air conditioning system at the Brantford Civic Centre \$1,625,000; and

ii. Leasehold improvement allowance - \$3,000,000.
