A By-law to close Pipe Street

<u>WHEREAS</u> the Municipal Council of The Corporation of the City of Brantford has caused public notice of its intention to consider a By-law for closing Pipe Street, in the City of Brantford.

<u>AND WHEREAS</u> the proposed By-law came before Council at its meeting on Tuesday the 28th day of February, 2023 starting at 6:00 o'clock in the evening at which time and place any person claiming to have property that would be affected by the proposed By-law and applied to be heard had an opportunity to be heard, either personally or by his counsel, solicitor or agent.

<u>AND WHEREAS</u> the Municipal Council has heard those persons who claim that their land would be affected by the By-law and who applied to be heard and has determined that the passing of this By-law is in the interest of the municipality.

- 2) The Corporation of the City of Brantford is hereby authorized to convey or reserve out of any sale of the road as closed any easement or easements required to protect public utilities and works located in, along, or over the road as closed.
- 3) There shall be attached hereto as Schedule "B" an Affidavit with respect to public notice of the By-law.
- 4) That this By-law shall take effect from and after the passing thereof.
