2.0 Topic Banbury Road – On-street Parking Amendment [Financial Impact - None]

3.0 Recommendation

- A. THAT report no. 2023-339 regarding "Banbury Road On-street Parking Amendment" BE RECEIVED; and
- B. THAT "Parking Prohibited at Anytime" BE APPROVED on the south side of Banbury Road from Orkney Place to a point 32 metres east of the centre line of Orkney Place; and
- C. THAT the necessary by-law BE PRESENTED to City Council for adoption.

4.0 Background

Public Works-021 Amending On-street Parking Regulations policy ("Policy") was approved by City Council in November 2019. The policy gives staff delegated authority to prepare parking control amending by-laws to City Council when staff recommendation and public feedback align.

When staff recommendation and public feedback do not align, as greater than 25% of the affected households in the neighbourhood oppose the proposed onstreet parking amendment, staff do not have delegated authority to proceed and must prepare a report to the Vision Zero Road Safety Committee ("VZRSC") for consideration. The requirement of the VZRSC is to decide whether or not to proceed with the recommended parking control amendment and report to the Committee of the Whole – Operations with the VZRSC's recommendation.

Operational Services received a request to prohibit on-street parking on the south side of Banbury Road, east of Orkney Place, to improve sightlines and access for motorists on Orkney Place.

A parking amendment letter, dated February 15, 2023, was delivered to eleven households on Banbury Road between Orkney Place and Normandy Place. The letter is attached as Appendix "A" to this report.

5.0 Analysis

Staff received concern regarding restricted sightlines turning from Orkney Place on to Banbury Road, when vehicles are parked on the south side of Banbury Road east of the intersection. No collisions have been reported at this intersection in the past five (5) years.

Staff received feedback and a petition, representing nine of the eleven (82%) affected residents, opposing the proposed parking control amendment. The level of opposition resulted in the need for staff to write a report for discussion and recommendation at the VZRSC.

Staff received (2) responses to the parking amendment letter; both opposed to the proposed parking control because cars parking too close to driveways restrict access. A resident led petition was submitted to staff during the comment period stating:

"We, the undersigned, are concerned property owners who strongly disagree with your request for on-street parking amendment on Banbury Road, Brantford (from Orkney Place to Normandy Place)".

The level of opposition from the residents initiated additional discussion. The residents agreed there are sightline issues when vehicles are parked in-front of 183 and 185 Banbury Road. However, they opposed "No Parking" on the entire block.

Staff considered the resident's concerns and recommend "No Parking" be bylawed in-front of 183 and 185 Banbury Road. On-street parking is currently prohibited in front of 185; the proposed amendment would extend "No Parking" easterly to include 183 Banbury Road. The proposed No Parking zone is illustrated in Figure 1 below.



Figure 1 - Banbury Road - Proposed No Parking Zone

Staff recommend that Schedule "7" of Parking By-law 144-88, which pertains to "Parking Prohibited at Anytime", be amended as outlined in Appendix "B" to this report.

6.0 Financial Implications

The cost to install "No Parking" signage is approximately \$200. Signage and installation will be funded from the Operational Services operating budget.

7.0 Climate and Environmental Implications

There are no climate and environmental implications resulting from this report.

8.0 Conclusion

The VZRSC is to review the requested parking control amendment to determine if it should be brought forward to Committee of the Whole - Operations for consideration.

Staff recommend that on-street parking be prohibited in front of 183 and 185 Banbury Road to address sightline concerns.

Following City Council's decision of the VZRSC recommendation, staff will update the City of Brantford parking website to provide the affected neighbourhood with an update of the parking control review.
