A. THAT Report 2023-356 Community Safety and Well-Being Plan – Two Year Review BE RECEIVED

4.0 Executive Summary

On March 9, 2018, the Provincial Legislature passed Bill 175, Safer Ontario Act, 2018, requiring all municipalities to develop a Community Safety and Well-being Plan (CSWB).

This legislation directed municipalities to work with community partners to develop projects and programs to create positive outcomes within identified priority areas. Municipalities were required to submit these plans to the Ministry of the Solicitor General prior to the end of July 2021.

The Brantford CSWB 2021-2025 was approved by Brantford City Council and submitted to the Province of Ontario in June 2021. There is currently no formal Provincial reporting requirements or funding associated with Community Safety and Well-being Plans.

In Brantford, this work was led by the CSWB Advisory Committee comprised on elected officials, civic leaders and subject matter experts from a variety of community organizations.

The CWSB re-affirmed Council and community priorities within six categories, and serves as a tracking mechanism for a number of municipal plans and initiatives.

This report does not provide specific details within each priority, but rather provides brief updates, with links to detailed reports related to each action, where available.

Many of the identified plans and strategies have milestones and metrics that are reported separately to Council (ex. Climate Change Action Plan, Healthy Aging Plan, Empower Youth Strategy, Vision Zero, Building the Community from the Kids Up).

As seen in *Appendix A: CSWB Two-year Review*, all actions are either complete or in-progress, with a number of significant deliverables related to security, housing, green space, older adults and traffic safety, to name a few.

Since 2021 the City of Brantford has endorsed two additional plans that support the goals of the CSWB, namely the *Downtown Brantford Priority Plan and* the *Building the Community from the Kids Up*, which have been added as 'new' actions within the CSWB,

The full CSWB Plan (2021-2025) is provided as Appendix B.

5.0 Purpose and Overview

This report provide a mid-term status update on the four-year Community Safety and Well-Being Plan.

6.0 Background

On March 9, 2018, the Provincial Legislature passed Bill 175, Safer Ontario Act, 2018, requiring all municipalities to develop a Community Safety and Well-being Plan. This legislation directed municipalities to work with community partners to develop projects and programs to create positive outcomes within identified priority areas.

The Safer Ontario Act, 2018, stipulated that City Council must create an Advisory Committee to support the development of the plan, with membership that included representation from the health, education, social services, children and youth services, municipal and police sectors.

In June 2021, Council approved the following Recommendations:

- A. THAT Report 2021-389 Community Safety and Well-being Plan: Final Approval BE RECEIVED; and
- B. THAT Appendix A City of Brantford's Community Safety and Well-being Plan 2021-2025 BE ADOPTED; and
- C. THAT Staff BE DIRECTED to inform the Ministry of the Solicitor General that the Plan has been adopted in accordance with the Safer Ontario Act, 2018; and
- D. THAT the Community Safety and Well-Being Advisory Committee BE DISBANDED having completed its mandate and that a By-law to amend Chapter 26 (Boards - Advisory Committees Duties – Functions) of the City of Brantford Municipal Code by repealing Schedule '25' BE PRESENTED to City Council for adoption.

7.0 Corporate Policy Context

The deliverables of the CSWB are closely aligned with Council-approved plans related to traffic safety, environmental sustainability, age-friendly planning, youth engagement, and cultural inclusivity, just to name a few.

- Older Adults
- Safe and Vibrant Neighbourhoods
- Substance Use

This CSWB was designed to support and re-affirm Council's priorities and plans related to traffic safety, security response, age-friendly planning, downtown revitalization, youth engagement, and housing.

The design of the CSWB also recognizes that municipal government can provide leadership in areas within the municipal scope, advocate for needed community resources and policy change in areas outside of the municipal scope, and commit to actively supporting the goals of existing community groups through ongoing engagement, collaborative projects and grant writing.
