WHEREAS The City of Brantford has demonstrated a commitment to community based programming and Asset Based Community Development; and

WHEREAS The City of Brantford Neighbourhood Association Policy and the network of active neighbourhood associations is the City's strongest example of ABCD in which residents are actively engaged in fostering safe, caring, strong and resilient neighbourhoods; and

WHEREAS The City of Brantford Affiliation Policy is another excellent example of the City's commitment to supporting local grass roots organizations and community groups seeking support and resources to help build community capacity and improve quality of life for Brantford residents; and

WHEREAS through the Neighbourhood Association Policy and Affiliation Policy, access to free space is made possible for community gathering, resident advocacy and resident led action; and

WHEREAS numerous other citizens, groups and organizations are leading important community development initiatives in the City of Brantford; and

WHEREAS through the Neighbourhood Alliance of Brantford (NAB), annual neighbourhood project grants are awarded to Neighbourhood Association citizenled projects that build community from the ground up; and

WHEREAS The City of Brantford is a proud partner of the ABCD Symposium taking place May 31st, 2023 at Mohawk Park Pavilion. This year's theme is "BELONGING":

NOW THEREFORE BE IT RESOLVED:

- A. THAT City staff from all departments BE ENCOURAGED to learn about ABCD and participate in this free, full-day ABCD symposium; and
- B. THAT staff BE DIRECTED to develop an internal process to utilize principles from ABCD in development of programs, services and public engagement and include examples and outcomes within a Council Priorities Update Report under Strategic Theme 6 "effectively and consistently engage with the community"; and
- C. THAT staff BE DIRECTED to explore staff training opportunities to develop a better understanding of ABCD principles and include any resource requirements within respective departmental training budgets; and
- D. THAT staff BE DIRECTED to INVESTIGATE adding a new section to the staff report template to summarize community and neighbourhood impact and REPORT BACK with options; and
- E. THAT staff BE DIRECTED to update the City's current "Community Involvement Framework" to include the principals of ABCD, and to coordinate a presentation about ABCD to the Public Consultation Task Force for consideration of the Members.

8. NOTICES OF MOTION

Councillor Samwell read the title of the following Notice of Motion:

8.1 Central Park Community Garden Water Service - Mandy Samwell

WHEREAS on June 19, 2017 the Downtown Community Neighborhood Association (DCNA) partnered with Equal Grounds Community Garden (EGCG) and volunteers from both associations, along with students from central public school, installed Brantford's 33rd garden (at the time) the at Central School located at 135 George Street; and

WHEREAS the school expansion in 2020 required the community garden to be removed; and

WHEREAS this garden not only provided food for the downtown community but created a safe place for those to turn to, it built a community of passionate community members who tended to the garden a sense of belonging and it provided the students at central public-school with education, pride and accomplishment as they helped implement, tend to and harvest the seeds at the end of season; and

WHEREAS food insecurity is at an all-time rise before the pandemic and certainly as continued to rise during and after the pandemic; and

WHEREAS the DCNA goal is to alleviate food insecurity for downtown members and for 222 children that are fed through Gifts of the Heart along with the 45 families we support during the week. The gardens provides hope, community, belonging and a place to turn to for food; and

WHEREAS both the DCNA and the Gifts of the Heart are committed to ensuring no food goes to waste and will work together with the downtown community to tend to the gardens and rescue all un used food before it spoils to break down and process in order to use in our children's lunches; and

WHEREAS recent playground upgrades provides the DCNA with an excellent location for re-establishment of the community gardens that were lost in 2020; and

WHEREAS the DCNA through EGCG will complete and submit the application form to the Community Garden Committee (2023 deadline April 1, 2023) and, if approved, enter into a Community Garden License Agreement for the 2024 growing season; and

WHEREAS to accommodate the proposed community gardens, appropriate water servicing complying to City Standards is recommended;

NOW THEREFORE BE IT RESOLVED:

- A. THAT following approval from the Community Garden Committee, City Staff BE DIRECTED to construct a park service complete with meter chamber and parks service box; and
- B. THAT City Staff BE DIRECTED to engage and retain appropriate professional Contractor and to fund these costs, estimated to be \$25,000, from the Council Priorities Reserve RF0558.
