# 8.1 Bell Court Redevelopment 40 Long Term Care beds, Day and Stay expansion, Sprinkler Project update Report and Capital Funding Request [Financial Impact- \$26,772,291] (JNH2023-28)

A. THAT the Bell Court Redevelopment of 40 Long Term Care beds, expansion of the Day and Stay and Sprinkler Project report JNH2023-28 BE RECEIVED and;

- B. THAT THE City of Brantford and the County of Brant be requested to provide the required capital funding for the projects.
- S. Proulx summarized the report given to the Committee. S. Proulx noted that a meeting may be required by the Committee of Management during the summer for any approvals, suggested to be at the call of the chair.

THAT the Committee of Management may be required to meet at the call of the chair during the summer BE APPROVED.

Voted on and approved unanimously.

Councillor Bell questioned if a 5% contingency is enough for this project? P. Goodfellow answered that the Construction Management Team have completed investigations within the building and risks of unknown identified are being actively mitigated. P. Goodfellow noted that budgeting at this time is sufficient to support the project within the scope understood.

Councillor Bell questioned the status of engineering design completion? P. Goodfellow summarized the various class estimates. The team will be releasing all of the documents to the Construction Manager on Friday and are confident in the budget and level of detail. Returned tenders are to be submitted by a target date of July 28<sup>th</sup>.

Councillor Bell questioned why the decision has to be made now? S. Proulx noted that the project needs both Councils approval for budget changes before proceeding. Both Councils take a summer break, and the final estimate is to be submitted by July. The recommendations are needed in order to submit for Ministry deadlines. If postponed to wait for tender, the project would not meet these deadlines.

Councillor Bell proposed an amendment to the motion to increase the contingency by 5%.

Moved by Councillor Bell Seconded by Councillor Coleman

#### Amendment:

A. THAT the Bell Court Redevelopment of 40 Long Term Care beds, expansion of the Day and Stay and Sprinkler Project report JNH2023-28 BE RECEIVED and;

THAT the following clause be added as Clause B:

- B. THAT the total requested capital funding in the amount of \$26,772,291 be increased by a total of \$1,100,000 for a new total project cost of \$27,872,291 and;
- C. THAT THE City of Brantford and the County of Brant be requested to provide the required capital funding for the projects

Councillor MacAlpine questioned what the original budget was? S. Proulx stated \$21,000,000. S. Proulx noted that the Sprinkler Project has been added since the original budget.

Councillor Bell questioned if there are comparables for bed redevelopments in LTC? P. Goodfellow shared that G. Architects are currently involved in 22 LTC redevelopment projects and additions across Ontario. He noted that similar numbers are being received from comparable projects. Councillor Bell asked what is the cost per bed for the project compared to others? P. Goodfellow stated the cost per bed for the project is \$550,000, but he is unable to share the cost per bed for other projects.

Item 8.1 as amended was voted on and approved.

- A. THAT the Administrator be AUTHORIZED to award the contract for 1:1 Support Worker/Security Guard services to Edmond Protection & Consulting Inc. (EPC) for the period July 1, 2023 to July 2, 2024 with the potential for a 1 year extension upon agreement by both parties and;
