4.0	Background	

It has been the intent of Planning and Development Services Staff to create terms of reference for Heritage Impact Assessments (HIA) and Heritage Conservation Plans (HCP). The adoption of terms of reference will provide

guidance to those preparing or reviewing HIAs and HCPs and help achieve a consistent standard of reporting on heritage matters for *Planning Act* applications and for Environmental Assessments.

Staff have considered terms of reference in use by other municipalities as well as recent legislative and procedural changes to the *Planning Act* which have impacts on the development process. New terms of reference have been drafted for both Heritage Impact Assessments (see **Appendix A**) and Heritage Conservation Plans (see **Appendix B**).

These terms of reference will be incorporated into the City's Development Manual project. All terms of reference for studies that the City could require to support a *Planning Act* application will be made available publicly on the City's website.

7.0 Conclusion

The City of Brantford's Planning and Development Services department is preparing a Development Manual to assist applicants. The Brantford Heritage Committee is being requested to provide comments for Staff's consideration as the Heritage Impact Assessment and Heritage Conservation Plan Terms of Reference are finalized.
