

BY-LAW NUMBER 138-2024

OF

THE CORPORATION OF THE CITY OF BRANTFORD

Being a By-law to amend By-law 70-2010 as amended, being a By-law to Adopt Various City of Brantford Policies and to Create a Corporate Policy Manual, by amending Corporate Policy – 048 – Municipal Street Naming Policy

WHEREAS under Section 8(1) of the *Municipal Act, 2001, S.O., 2001, c.25*, as amended, the powers of a municipality shall be interpreted broadly so as to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues; and

WHEREAS, at its meeting of June 7, 2010, City Council passed By-law 70-2010, being a By-law to adopt various policies of the City of Brantford and to create a Corporate Policy Manual, which policies are attached thereto as Appendix "A"; and

WHEREAS, at its meeting of November 24, 2020, City Council passed By-law 191-2020, being a By-law to amend By-law 70-2010 by adding Corporate Policy – 048 (Municipal Street Naming Policy) to Appendix "A" attached thereto; and

WHEREAS, at its meeting on June 25, 2024, City Council adopted the recommendations set out in item 12.4.16 of Committee of the Whole – Planning and Administration Report #2024-06-11, to amend Corporate Policy – 048 (Municipal Street Naming Policy) to prioritize the assignment of the name "Sterne" as a street name in an industrial subdivision to honour the late Richard (Rick) Sterne;

NOW THEREFORE BE IT RESOLVED THAT THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF BRANTFORD ENACTS AS FOLLOWS:

1. THAT Appendix "A" attached to By-law 70-2010 as amended is hereby amended by repealing and replacing Section 1.2 (Priority Assignment of Street Names) in Corporate Policy – 048 (Municipal Street Naming Policy) with a new Section 1.2 (Priority Assignment of Street Names) as follows:

**“1.2 Priority Assignment of Street Names**

Street names shall be assigned in priority according to the following:

Priority 1 The next street name(s) to be assigned, subject to any noted conditions, shall be:

Finney – Honouring Kevin Finney (Condition: to be used in the next industrial subdivision); and

Sterne – Honouring Richard (Rick) Sterne (Condition: to be used in an industrial subdivision)

Priority 2 Veterans who have made the Supreme Sacrifice

Priority 3 Names from any of the Categories of Pre-Approved Street Names as listed in Section 1.1. of this Policy”

2. THAT the Clerk be directed to update the Corporate Policy Manual to reflect the amendment to said Policy approved herein; and
3. THAT this By-law comes into force on the date of its passing.
