## **BY-LAW NUMBER 179-2024**

## THE CORPORATION OF THE CITY OF BRANTFORD

## To amend Parking By-law 144-88, being a by-law to regulate Parking in the City of Brantford

WHEREAS Committee of the Whole – Operations of Council of the Corporation of the City of Brantford has recommended to Council for the improvement and better regulation of parking within the City of Brantford; and

WHEREAS Council desires to implement the recommendations of the Committee as aforesaid;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF BRANTFORD ENACTS AS FOLLOWS:

- 1. Murray Street / East Ward Neighbourhood Traffic Review
  - a) THAT Schedule "7" of Parking By-law 144-88 which pertains to "Parking Prohibited at Anytime" BE REPEALED as follows:

| Colborne Street  By-law 112-2023 | South             | From Park Avenue to a point 28.5 metres west of the centre line of Park Avenue. |

b) THAT Schedule "7" of Parking By-law 144-88 which pertains to "Parking Prohibited at Anytime" BE AMENDED to provide the following:

|-------------------|-----------------------------|---|
| Colborne Street   | North                       | From Drummond Street to a point 30 metres west of the centre line of Drummond Street. |
| Colborne Street   | South                       | From Drummond Street to a point 20 metres west of the centre line of Drummond Street. |
| Colborne Street   | South                       | From Park Avenue to a point 41 metres west of the centre line of Park Avenue.         |
| Colborne Street   | North                       | From Peel Avenue to a point 21 metres west of the centre line of Peel Avenue.         |

c) THAT Schedule "10" of Parking By-law 144-88 which pertains to "Parking- Restricted Time Limit" BE REPEALED as follows:

| Colborne Street   | South             | From Alfred Street to a point 41 metres west of the centre line of Park Avenue, except as provided for in Schedule "16" | 1 hour<br>8am to 6pm | Monday through<br>Saturday            |

2. THAT this by-law shall become effective upon the date of its passing, save and except that any provisions of this by-law affecting traffic on highways designated as connecting links, pursuant to Subsection 195(3) of The Highway Traffic Act, as amended, and Subsection 21(1) of The Public Transportation and Highway Improvement Act, as amended, shall not become operative until approved by the Ontario Ministry of Transportation.
