8.1 International Mother Language Day - February 21, 2025

Councillor Samwell read the Proclamation for International Mother Language Day - February 21, 2025

WHEREAS Languages are essential to education and sustainable development, serving as the primary means through which knowledge is transferred and cultures are preserved; and

WHEREAS on February 21, 1952, a number of students from Dhaka University in Bangladesh were tragically killed during a demonstration advocating for the recognition of their mother language, Bangla (also known as Bengali). The observance of International Mother Language Day honors the sacrifice of these students and their unwavering advocacy for linguistic rights; and

WHEREAS Multilingual education, particularly for minority and indigenous languages, not only helps learners but also fosters a deeper connection between education and culture, contributing to more inclusive and equitable societies; and

WHEREAS The 25th anniversary of International Mother Language Day celebrates a quarter-century of efforts to preserve linguistic diversity and promote mother tongues; and

WHEREAS <u>International Mother Language Day</u>, first proclaimed by UNESCO and later adopted by the UN General Assembly, underscores the role of languages in promoting inclusion; and

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the City of Brantford HEREBY PROCLAIMS February 21, 2025 as International Mother Language day.; and that City Hall be lit up green in honour of International Mother Language day.

WHEREAS, On the 114th International Women's Day, the City recognizes the 2025 theme of "Accelerate Action," focusing on how collectively, we can accelerate action for gender equality.

8.3 Amyloidosis Awareness Month - March

Councillor Sullivan read the Proclamation for Amyloidosis Awareness Month - March

WHEREAS, March is Amyloidosis Awareness Month, a month dedicated to raising awareness, funding research, and supporting those living with amyloidosis and their loved ones; and

WHEREAS, Amyloidosis is a group of diseases that occurs when an abnormal protein, known as amyloid, builds up in the tissues and organs of the body. Left untreated, the disease can result in organ failure and can be fatal; and

WHEREAS, Amyloidosis can mimic the signs and symptoms of more common medical conditions and the disease can be challenging to diagnose; and

WHEREAS, Amyloidosis often affects people who are older or middle aged; however, younger people have been diagnosed with this disease; and

WHEREAS, Some of the signs and symptoms of amyloidosis can include shortness of breath, weight loss, fatigue, swelling in the ankles and legs, numbness in the hands and feet, foamy urine, carpal tunnel syndrome, bruising around the eyes, and an enlarged tongue; and

WHEREAS, Early diagnosis can lead to better outcomes for both patients and their families; and

WHEREAS, Raising awareness about all the amyloidosis diseases, including hereditary and non-hereditary forms of the disease, can contribute to the building of healthier communities across Canada.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the City of Brantford HEREBY PROCLAIMS March as Amyloidosis Awareness Month in the City of Brantford.

WHEREAS a thorough review and update of the Purchasing Policy will enhance the City's ability to effectively manage public funds while fostering economic development within the community;

NOW Therefore Be It Resolved that the Council of the Corporation of the City of Brantford directs the following:

- A. That the CAO work with staff to review opportunities to ensure a Canada-First approach in the city's procurement policies
- B. That City staff undertake a comprehensive review and update of the City's Purchasing Policy. This review should include, but not be limited to, the following actions:
 - i. Evaluate the internal spending limits
 - ii. A review of the use of Approved Vendor's lists, including how such lists are maintained and how procurement can be fairly and efficiently allocated to vendors on these lists;

C. City Staff to explore Methods to engage with, and to promote the participation of, local business in the City's procurement initiatives in a manner which still reflects fairness to all bidders:
