

**BY-LAW NUMBER 33-2025**  
**OF**  
**THE CORPORATION OF THE CITY OF BRANTFORD**

To amend Traffic By-law 37-83, being a by-law to regulate  
Traffic in the City of Brantford

WHEREAS Committee of the Whole – Operations of Council of the Corporation of the City of Brantford has recommended to Council for the improvement and better regulation of traffic within the City of Brantford; and

WHEREAS Council desires to implement the recommendations of the Committee as aforesaid;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF BRANTFORD ENACTS AS FOLLOWS:

1. Traffic By-law 37-83 Amendment

a) THAT Section 25(1)(a) of Traffic By-law 37-83 which pertains to “Truck Route Regulations” BE REPEALED as follows:

(1) In this Bylaw:

(a) a "Truck" means a commercial vehicle designed for the transportation of cargo and having more than four tires; but does not include:

- passenger vehicle
- a six tire pick-up truck
- Municipal or Utility vehicles which are used for construction or maintenance of facilities
- an ambulance or any vehicle of the Police or Fire Departments
- a school bus or Public Utilities bus
- a motor home or travel trailer

b) THAT Section 25(1)(a) of Traffic By-law 37-83 which pertains to “Truck Route Regulations” BE AMENDED to provide the following:

(1) In this By-law:

(a) a "Truck" means a commercial vehicle designed for the transportation of cargo with a registered gross weight of more than 4,500 kilograms (4.5 tonnes); but does not include:

- passenger vehicle
- a six-tire pick-up truck
- Municipal or Utility vehicles which are used for

- construction or maintenance of facilities
- an ambulance or any vehicle of the Police or Fire Departments
- a school bus or Brantford Transit bus
- a motor home or travel trailer

2. Traffic By-law 37-83 Schedule Amendments – Truck Routes

a) THAT Schedule “9” of Traffic By-law 37-83 which pertains to “Gross Weight on Bridges” BE REPEALED as follows:

Morrell Street	From Grand River Avenue to Charlton Avenue	
Mt. Pleasant Street	From Colborne Street West to Gilkison Street	
Mt. Pleasant Road	From Gilkison Street to the southern City limits	
Oak Park Road	From Hardy Road to Powerline Road	
Shellard Lane	From Veterans Memorial Parkway to the western City limits	
Veterans Memorial Parkway	From Colborne Street West to Erie Avenue	
Wayne Gretzky Parkway	From Colborne Street to Powerline Road	
West Street	From Fairview Drive to Brant Avenue	

2. THAT this by-law shall become effective upon the date of its passing, save and except that any provisions of this by-law affecting traffic on highways designated as connecting links, pursuant to Subsection 195(3) of The Highway Traffic Act, as amended, and Subsection 21(1) of The Public Transportation and Highway Improvement Act, as amended, shall not become operative until approved by the Ontario Ministry of Transportation.
