OF
THE CORPORATION OF THE CITY OF BRANTFORD

To amend By-law Number 144-88, being a by-law to regulate
Parking in the City of Brantford

WHEREAS By-law 177-2019, enacting Public Works-021 Policy to Amend On-Street Parking Regulations was approved by City Council on November 19, 2019; and

WHEREAS the policy permits Parking By-law Amendments meeting specific criteria to be placed before City Council without first being considered by Committee of the Whole – Operations; and

WHEREAS the following amendments meet the criteria of Public Works-021 Policy and will allow for improvement and better regulation of parking within the City of Brantford;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF BRANTFORD ENACTS AS FOLLOWS:

1. Sheridan Street – Pick Up Zone

- a) THAT Schedule “7” of Parking By-law 144-88 which pertains to “Parking Prohibited at Anytime” BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Sheridan Street	North	From Market Street to Clarence Street

- b) THAT Schedule “7” of Parking By-law 144-88 which pertains to “Parking Prohibited at Anytime” BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Sheridan Street	North	From Clarence Street to Charlotte Street
Sheridan Street	North	From George Street to a point 62 metres east of the centre line of George Street
Sheridan Street	North	From George Street to Market Street

- c) THAT Schedule “16” of Parking By-law 144-88 which pertains to “Pick Up Zones” BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION OF PICK-UP ZONE</u>	<u>PERIOD OF TIME</u>
Sheridan Street	North	From a point 22 metres west of the centre line of Charlotte Street for a distance of 57 metres westerly	15 Minutes 7 am – 6 pm Monday through Friday September 1 to June 30

2. Hachborn Road – Parking Prohibited at Anytime

- a) THAT Schedule “7” of Parking By-law 144-88 which pertains to “Parking Prohibited at Anytime” BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Hachborn Road	Both	From Braneida Lane to the westerly end of Hachborn Road

- b) THAT Schedule “7” of Parking By-law 144-88 which pertains to “Parking Prohibited at Anytime” BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Hachborn Road	North	From a point 105 metres west of the centre line of Braneida Lane to the westerly end of Hachborn Road.
Hachborn Road	South	From Braneida Lane to the westerly end of Hachborn Road

3. Balmoral Drive – Parking Prohibited at Anytime

- a) THAT Schedule “11” of Parking By-law 144-88 which pertains to “Alternate Side of Street Parking” BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>LOCATION</u>	No parking from 12 noon, 1 st day of each month until 9 pm, 15 th day of each month, Monday through <u>Saturday</u> .	No Parking from 12 noon, 16 th day of each month until 9 pm, last day of each month, Monday through <u>Saturday</u>
Balmoral Drive	From Oxford Street to Miles Avenue, except as further restricted in Schedule '5' herein	East	West

- b) THAT Schedule "7" of Parking By-law 144-88 which pertains to "Parking Prohibited at Anytime" BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING IS PROHIBITED</u>
Balmoral Drive	West	From a point 15 metres north-westerly of the centre line of Eden Lane south-easterly for 30 metres.

- c) THAT Schedule "7" of Parking By-law 144-88 which pertains to "Parking Prohibited at Anytime" BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING IS PROHIBITED</u>
Balmoral Drive	West	From a point 18 metres north-westerly of the projected centre line of Oxford Street to Somerset Road.

4. Flanders Drive – Stopping Prohibited During Certain Time

- a) THAT Schedule "8" of Parking By-law 144-88 which pertains to "Stopping Prohibited During Certain Time" BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION</u>	<u>TIMES WHEN STOPPING PROHIBITED</u>
Flanders Drive	North	From a point 31 metres east of the centre line of Richter Street for a distance of 106 metres easterly	8:30 am to 9:30 am & 3 pm to 4 pm Monday through Friday September 1 to June 30

- b) THAT Schedule “8” of Parking By-law 144-88 which pertains to “Stopping Prohibited During Certain Time” BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION</u>	<u>TIMES WHEN STOPPING PROHIBITED</u>
Flanders Drive	North	From a point 31 metres east of the centre line of Richter Street for a distance of 106 metres easterly	8:00 am to 9:00 am & 3 pm to 4 pm Monday through Friday September 1 to June 30

5. Wellington Street – Accessible Zone

- a) THAT Schedule “26” of Parking By-law 144-88 which pertains to “Accessible Zone” BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION OF EXCLUSIVE ACCESSIBLE PARKING ZONE</u>
Wellington Street	South	From a point 81 metres east of the centre line of Alfred Street for a distance 6 metres easterly

6. Elgin Street – Parking Prohibited During Certain Time

- a) THAT Schedule “9” of Parking By-law 144-88 which pertains to “Parking Prohibited During Certain Time” BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION</u>	<u>TIMES WHEN PARKING IS PROHIBITED</u>
Elgin Street	North	Commencing 58 metres west of the centre line of Murray Street westerly for 18 metres	7 am to 4 pm Monday through Friday

- b) THAT Schedule “9” of Parking By-law 144-88 which pertains to “Parking Prohibited During Certain Time” BE AMENDED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION</u>	<u>TIMES WHEN PARKING IS PROHIBITED</u>
Elgin Street	North	Commencing 41 metres west of the centre line of Murray Street westerly for 49 metres	7 am to 4 pm Monday through Friday

- c) THAT Schedule “10” of Parking By-law 144-88 which pertains to “Parking – Restricted Time Limit” BE REPEALED as follows:

Elgin Street	North	Commencing 20 metres west of the centre line of Murray Street westerly for 38 metres	1 hour 8 am to 6 pm	Monday through Friday

- d) THAT Schedule “10” of Parking By-law 144-88 which pertains to “Parking -Restricted Time Limit” BE AMENDED to provide the following:

Elgin Street	North	Commencing 20 metres west of the centre line of Murray Street westerly for 21 metres.	1 hour 8 am to 6 pm	Monday through Friday

7. Dufferin Avenue – Permit Parking

- a) THAT Schedule “10” of Parking By-law 144-88 which pertains to “Parking – Restricted Time Limit” BE REPEALED as follows:

Dufferin Avenue	North	From the south leg of Lorne Crescent to the north leg of Lorne Crescent.	2 hours 9 am to 5 pm	Monday through Friday

- b) THAT Schedule “30” of Parking By-law 144-88 which pertains to “Time Limit Exemption Areas” BE REPEALED as follows:

8. Lorne Crescent – Parking Prohibited at Anytime

Lorne Crescent	South	From Jarvis Street to a point 39 metres west of the projected centre line of Dufferin Avenue (east intersection)

Lorne Crescent North	North	Commencing 8 metres west of Brant Avenue for 7 metres westerly	15 Minutes

- b) THAT Schedule “10” of Parking By-law 144-88 which pertains to “Restricted Time Limit” BE AMENDED to provide the following:

Lorne Crescent	North	Commencing 8 metres west of Brant Avenue for 7 metres westerly	2 hours	Every Day

10. Dorothy Street – Restricted Time Limit Parking

- a) THAT Schedule “10” of Parking By-law 144-88 which pertains to “Parking – Restricted Time Limit” BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION</u>	<u>PERIOD OF TIME</u>	<u>DAYS OF WEEK PARKING RESTRICTED</u>
Dorothy Street By-law 262-88	North	From Erie Avenue to Heagerty Street, except as provided for in Schedule '7' and Schedule '8'.	2 hours 8 am to 6 pm	Monday through Friday

11. Hansford Drive – Parking Prohibited at Anytime

- a) THAT Schedule “7” of Parking By-law 144-88 which pertains to ““Parking Prohibited at Anytime” BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Hansford Drive	South	From a point 195 metres east of the centre line of Barrett Avenue for a distance of 31 metres easterly

12. Baxter Street – Parking Prohibited at Anytime

- a) THAT Schedule “7” of Parking By-law 144-88 which pertains to “Parking Prohibited at Anytime” BE AMENDED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Baxter Street	East	From Fairview Drive to a point 42 metres south of the centre line of Fairview Drive

13. Ellenson Drive – School Bus Loading Zone

- a) THAT Schedule “19” of Parking By-law 144-88 which pertains to “School Bus Loading Zone” BE REPEALED as follows:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Ellenson Drive By-law 28-91	West	Commencing 90 metres south of centre line of Evelyn for 15 metres southerly

- b) THAT Schedule “19” of Parking By-law 144-88 which pertains to “School Bus Loading Zone” BE AMENDED to provide the following:

<u>NAME OF STREET</u>	<u>SIDE OF STREET</u>	<u>LOCATION WHERE PARKING PROHIBITED</u>
Ellenson Drive	West	Commencing 75 metres south of centre line of Evelyn Street for 75 metres southerly

14. THAT this by-law shall become effective upon the date of its passing, save and except that any provisions of this by-law affecting traffic on highways designated as connecting links, pursuant to Subsection 195(3) of The Highway Traffic Act, as amended, and Subsection 21(1) of The Public Transportation and Highway Improvement Act, as amended, shall not become operative until approved by the Ontario Ministry of Transportation.
