- D. THAT staff BE DIRECTED to pause all non-essential conferences and trips to the US until further notice; and
- E. THAT staff BE DIRECTED to continue engaging with local industries and businesses to determine what municipal supports will be needed to alleviate or mitigate the adverse impacts of US tariffs on these local businesses and industries; and

- F. THAT staff BE DIRECTED to review and adjust the 2024-2031 Economic Development strategy with a further goal of increasing the resiliency of Brantford's economy from the impact of external influences such as international trade conflicts; and
- G. THAT staff BE DIRECTED to undertake the following actions in response to the current situation regarding potential US tariffs:
  - i. Foreign Direct Investment Marketing Initiatives
  - ii. US Export Webinars
  - iii. US Tariff Resources Webpage
  - iv. Regional Collaboration on US Tariff Response
  - v. Buy Local and Buy Canadian Promotions
  - vi. Continued Development of Local Tourism Products; and
- H. THAT the Municipal Working Group on Trade Procurement BE DIRECTED to continue to meet and bring forward a monthly report to Committee of the Whole Planning and Administration until such a time that the US tariff situation eases or is resolved, in consultation with the Mayor and the Chief Administrative Officer.
