Steve Charest, Trevor Fronchak, Pete Kyte representing King & Benton Redevelopment Corporation regarding Item 4.1

- P. Kyte and T. Fronchak were present representing King & Benton Redevelopment Corporation.
- Steve Charest, owner of King & Benton Redevelopment Corporation is against designation of 60 Market Street South as a heritage property. King & Benton Redevelopment Corporation has owned the property for two years and recognizes the cultural and heritage values of the train station. They plan to make the architecture and history of the building a focal point and would be willing to put it in writing that no changes will be made to the architecture.
- In response to questions, P. Kyte noted they would like to avoid the additional submission processes resulting from a heritage designation, as time compounds into money with extra processes.
- In response to questions, P. Kyte noted that they are aware of the City's Heritage Grant program that provides financial assistance to property owners to restore heritage properties, but the dollar amount offered does not counteract.
- R. Adlam suggested that perhaps conservation easements could be an option alongside or separate from designation.

 In response to questions, T. Fronchak noted that King & Benton Redevelopment Corporation owns both 60 Market Street South and the neighbouring property fronting Clarence Street, as well as a strip of land that was the former CN Rail lands.
