## 4.1 Property Standards Order #01-19 - Notice of Appeal - 97 Charlotte Street, Brantford (2019-89)

G. Anderson, Manager of Property Standards and By-laws, provided an overview of the appeal to the Committee. The preliminary inspection occurred on June 20, 2018 and Officers noted a number of deficiencies including but not limited to defective soffit, fascia and a defective hand rail. The order was issued and the appeal was filed on January 10, 2019 indicating additional time to complete the repairs. Staff are requesting the order be confirmed and upheld.

J. Hunter, Property Standards Officer informed the Committee that as of inspection today, no changes have occurred on the property.

In response to questioning, Staff informed that the original letter was sent in June 2018 and there was no communication from the owner.

Joe Persaud appeared before the Committee on behalf of Mr. Amar Hamamy. He has requested an extension of 6 months on the order. J. Persaud informed the committee that no repairs have been completed as the contractor has been unable to come and that the owner would like to do all repairs at once.

Staff informed the Committee that six months is too much time for the repairs of this nature and it is not recommended.
