### **4.1** Social Media Plan and Strategy – M. Visocchi, Communications

M. Visocchi provided an overview of the draft social media plan and strategy. The plan includes key messages and outlines the strategy for social media platforms as well as a City Web Page. The Committee was then provided with an opportunity to ask questions to staff.

Chair Lawrie Palk asked if there would be more focus on the quantity of content, or less-frequent, in-depth posts. M. Visocchi explained that both approaches will be used. During time periods approaching long weekend or holidays, messaging will be increased in order to bring awareness to the potential impaired driving issues that are associated with such holidays.
