The official plan review began in 2013 and a Statutory Public Hearing will be held on November 19, 2020 starting at 3:30 p.m.

Staff stated that the announcements of the Public Hearing regarding the Official Plan has gone out in the form of official notice as well as social media advertising through the Communications Department.
