4.0 **Executive Summary**

This report provides City Council information on the need to by-law the Fire Route at the condominium complex at 77 Diana Avenue. This will enable the Brantford Police Service and the City's Parking Enforcement Officers to enforce parking restrictions along the designated Fire Route. The property representative has completed all the necessary steps to have the internal travel route by-lawed as a Fire Route.

5.0 **Purpose and Overview**

To enable the Brantford Police Service and the City's parking enforcement staff provide parking enforcement along the designated Fire Route at 77 Diana Avenue.

6.0 Background

A representative from Wilson Blanchard Management has requested that 77 Diana Avenue, a condominium property, have their Fire Access Route added to Schedule "27" of the City's Parking By-law.

The City's Fire Department has reviewed and approved the installation of the required "No Parking, Fire Route" signs at the property.


8.0 Input from Other Sources
