- B. WHEREAS the Ontario Provincial Government is encouraging Municipalities across the province to adopt Tow Truck Regulations to assist in reducing violence and organized crime and enhance road safety; and

WHEREAS the City of Brantford deems it to be in the public interest, having regard for both public health and safety and consumer protection, to protect persons involved in motor vehicle accidents on local roads:

NOW THEREFORE, BE IT RESOLVED:

- A. THAT Staff BE DIRECTED to engage the public through a Let's Talk Brantford campaign in January to determine potential regulation for Towing Services as well as engaging with Community Partners including the Brantford Police Service, Brantford-Brant Chamber of Commerce and the Ministry of Transportation; and

WHEREAS the Nomination Committee has now completed its process and recommends Peter Ferraro, Gerry Remers and Terry Smith as the three additional independent directors for the Mergeco Holding Company board (the "Additional Independent Directors"); and

WHEREAS the Cambridge and North Dumfries Energy Plus Inc. board and the Brantford Power Inc. board both support the Nomination Committee's recommendation of the Additional Independent Directors; and

WHEREAS the Mergeco Holding Company board of directors has the power and authority to appoint directors to all subsidiary boards once incorporated, pursuant to the USA;

WHEREAS during construction of the Veterans Memorial Parkway and intersection realignment, the Council of the day committed to installing sufficient noise attenuation measures protecting the area residents from noise being generated by increasing traffic flows and volumes and,

WHEREAS residents of the Oakhill Drive community have expressed concern of high noise levels emanating from Colborne Street West, and

WHEREAS City Council directed staff to conduct a noise study along Colborne Street West for the determination of existing noise sources, noise levels, potential mitigation options and potential cost to the City to implement options identified in the study, and

WHEREAS report 2019-317 "Colborne Street West – Noise Study" was received by City Council and confirmed a continuous elevated noise level above guidelines stated by the World Health Organization and The Ontario Ministry of Transportation and Ministry of Environment, Conservation and Parks, and

WHEREAS report 2019-317 "Colborne Street West – Noise Study" indicated a continuous noise barrier adjacent to the residential properties would reduce the unwanted noise to approximately one third of the adjacent neighborhood, and
