BY-LAW NUMBER 10-2022

OF

THE CORPORATION OF THE CITY OF BRANTFORD

Being a By-law to amend By-Law No. 58-2019, as previously amended, (Being a By-law to authorize the Police Service Headquarters Relocation Project and to make provision for the financing of the foregoing)

WHEREAS, the Municipal Council of The Corporation of the City of Brantford passed By-law No. 58-2019 on April 22, 2019 to authorize the Police Service Headquarters Relocation Project and to make provision for financing of the project;

AND WHEREAS the Municipal Council of the Corporation of the City of Brantford passed By-law No. 212-2019 to authorize increased capital costs and to make provision for the updated financing of the project on December 18, 2019 to amend By-law No. 58-2019;

AND WHEREAS the project has been amended to be a Police Service Headquarters Redevelopment Project from the previous Police Service Headquarters Relocation Project;

AND WHEREAS the capital costs of undertaking the Police Service Headquarters Redevelopment Project are now estimated to be \$12,404,133 lower than previously authorized through By-law No. 58-2019, as amended;

AND WHEREAS the Municipal Council of the Corporation of the City of Brantford wishes to further amend By-law No. 58-2019, to decrease the estimated capital costs and update the name to the Police Service Headquarters Redevelopment Project;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF BRANTFORD ENACTS AS FOLLOWS:

- 1. By-law No. 58-2019, as amended, is hereby amended by deleting all references to the "Police Service Headquarters Relocation Project" and substituting the words "Police Service Headquarters Redevelopment Project".
- 2. By-law No. 58-2019, as amended, is hereby amended by deleting the amount of "\$51,404,133.00" from the first sentence in section 2 and substituting the number "\$39,000,000.00".
- 3. Subsection 2(a) of By-law No. 58-2019, as amended, is hereby amended by deleting the words and the numbers "forty-two million, six hundred and eighty-two thousand, nineteen dollars (\$42,682,019.00)" and substituting the words and the numbers "twenty-three million, seven hundred and nineteen thousand, seven hundred and thirty-nine dollars (\$23,719,739.00)".
- 4. Subsection 2(b) of By-law No. 58-2019, as amended, is hereby amended by deleting the words and numbers "one million, one hundred and five thousand, two hundred and fifty-seven dollars (\$1,105,257.00)" and substituting the words and the numbers "fifteen million, two hundred and eighty thousand, two hundred and sixty-one dollars (\$15,280,261.00)".

- 5. Subsection 2(c) be deleted from By-Law No. 58-2019, as amended.
- 6. Subsection 2(d) be renumbered as subsection 2(c) of By-law No. 58-2019, as amended.
- 7. Section 5 of By-law No. 58-2019, as amended, is hereby amended by deleting the words and numbers "forty-two million, six hundred and eighty-two thousand, nineteen dollars (\$42,682,019.00)" and substituting the words and the numbers "twenty-three million, seven hundred and nineteen thousand, seven hundred and thirty-nine dollars (\$23,719,739.00)".
- 8. The remaining sections in By-law No. 58-2019, as amended, shall remain unaltered.
- 9. This By-law comes into force and effect on the date of final passage hereof.
